### Professional Summary

Active in high-stakes litigation, Dori focuses her practice on crafting the trial and appellate strategy for cases in state and federal court. From the initial case evaluation through appeal, she takes the lead in developing the legal arguments, drafting pivotal trial pleadings and appellate briefs, handling error preservation, and presenting oral arguments. Known for her adept approach to jury charges and strategic case assessments, Dori has helped clients across industries achieve successful results in complex trials and appeals involving business contracts and torts, antitrust, bankruptcy, personal injury, and other commercial disputes. She has been engaged by leading trial attorneys across the state to assist during trials and all stages of appeals. Dori graduated from Harvard Law School, cum laude, and clerked for the Honorable Lee H. Rosenthal of the U.S. District Court for the Southern District of Texas. She received her undergraduate degree, magna cum laude, from Princeton University, where she was elected to Phi Beta Kappa and served as Executive Editor of The Daily Princetonian. Before attending law school, Dori was a policy analyst for the Electronic Privacy Information Center. Dori holds numerous professional and civic leadership roles. She serves as co-chair of the membership committees for the State Bar of Texas Appellate Section and the Women and The Law Section, and as a board member of the Anti-Defamation League Southwest Region and the Jewish Federation of Greater Houston. Dori's service to the profession and the community has led to honors, including the Joseph D. Jamail Award for Justice by AVDA, Women of Influence Award from the National Council of Jewish Women Greater Houston, the Kristi Couvillon Pro Bono Award from the Texas Civil Rights Project, and the Falik Young Leadership Award from the Jewish Federation of Greater Houston.

### Representative Experience

- Texas State Court: *Jfff Walker v. First National Bank* Served as appellate counsel in trial and appeal up to the Texas Supreme Court, with plaintiff successes valued at \$117 million.
- Texas Supreme Court: *CenterPoint Energy Houston Elec., LLC et al. v. Gulf Coast Coalition of Cities, et al.* Represented CenterPoint in a successful appeal

regarding the utility's multi-billion-dollar stranded-cost true-up following Texas's electric deregulation.

- United States Supreme Court: *Ricci v. DeStefano* Successfully represented in the U.S. Supreme Court a group of 20 New Haven firefighters in an Equal Protection Clause and Title VII lawsuit. The Supreme Court ruled 5-4 in our clients' favor, not merely reversing the summary judgment in favor of the City of New Haven, but further ruling that our clients were entitled to summary judgment in their favor on liability under the Title VII.
- Federal Court: *M.D. v. Abbott* Represented a class of 12,000 foster children care in a class action lawsuit that challenged pervasive failures in the Texas foster care system. After a two-week trial, the court issued a 255-page verdict finding widespread constitutional violations and appointed independent special masters.
- California State Court: *Peregrine Litigation Trust v. John J. Moores, et al.* Represented litigation trust in prosecution of insider trading and mismanagement claims against bankrupt corporation's former auditors, officers, directors, and business partners. The trust successfully settled its claims for what was believed to be the largest cash recovery ever paid by outside directors of a publicly-traded company.
- Federal Court: *ASARCO v. Augusta Resource, Inc., et. al.* Defended a publicly held mining company in an adversary proceeding alleging fraudulent transfer relating to the purchase of 20,000 acres of undeveloped land worth over \$400 million. The case settled on terms extremely favorable to our client, which paid only pennies on the dollar of plaintiff's claims and was able to maintain full and complete ownership of the property.
