- FTC v. Welsh, Carson, Anderson & Stowe. Defended Welsh Carson against FTC suit alleging anticompetitive practices against a private equity firm who allegedly engaged in "roll-up" transactions to monopolize anesthesia services in Texas. Secured dismissal of all claims against Welsh Carson in a landmark case establishing that a private equity investor in long-ago completed transactions cannot be sued for an "ongoing" violation of the antitrust laws. Also won dismissal of all claims against our client in the follow-on civil class action on statute of limitations grounds (Elec. Med. Trust & Plumber Local Union 68 v. USAP).

- U.S. Airways, Inc. v. Sabre Holdings Corp. Part of trial team representing U.S. Airways in antitrust lawsuit against the largest U.S. global distribution system. Following a three-week trial in the U.S. District Court for the Southern District of New York, the jury found that Sabre was a monopolist that abused its power and harmed US Airways and competition by practices meant to stifle innovation and new distribution technologies.
- Baker Hughes v. LSPI. Representing Baker Hughes in a plaintiff-side monopolization case related to the sale of Drag Reducing Agents for use in heavy crude pipelines. Case includes Walker Processand sham litigation claims.
- StarKist / Dongwon Industries . Represented StarKist and its parent company in multidistrict litigation proceedings alleging that it entered into a price-fixing conspiracy with Bumble Bee and Chicken of the Sea, and related DOJ investigation.*
- Hyatt. Represented major hotel chain in securing a favorable settlement in litigation alleging that it conspired to prevent online travel companies' use of trademarked keywords after the plaintiffs recognized that they could not obtain class certification.*

Energy

- Energy Transfer v. CPS Energy. Representing two affiliates of Energy Transfer in a dispute over \$250M+ in short-paid invoices for gas sold to the public utility in San Antonio during during Winter Storm Uri.
- U.S. v. PG&E. Represented the public utility in Northern California in a two-month criminal trial related to the explosion of a natural gas line.
 Successfully reduced PG&E's potential fine in the criminal case from US\$1.14 billion to US\$3 million. No individuals were indicted.*
