FINAL JUDGMENT

The Court having resolved all disputed issues, by various orders and summary judgments, against Plaintiffs Apollo Exploration, LLC, Cogent Exploration, LTD. Co. and Sellmoco, LLC, and in favor of Defendant Apache Corporation, the Court now renders a final judgment as follows:

It is ADJUDGED that Plaintiffs, Apollo Exploration, LLC, Cogent Exploration, LTD. Co. and Sellmoco, LLC, hereby take nothing by reason of their claims in this case.

It is further ADJUDGED AND ORDERED that Defendant Apache Corporation is entitled to recover from the Plaintiffs, jointly and severally, the sum of FOUR MILLION EIGHT HUNDRED THOUSAND AND NO/100 DOLLARS (\$4,800,000.00) in attorneys' fees incurred by Apache Corporation in proceedings in this case, together with all costs of court incurred by Apache Corporation, for which execution may issue.


It is further ADJUDGED AND ORDERED that, if an appeal is taken and Apache Corporation prevails on appeal, then Apache Corporation shall further recover from Plaintiffs, jointly and severally, THREE HUNDRED THOUSAND AND NO/100 DOLLARS (\$300,000.00) for fees in successfully defending this Judgment on appeal in the court of appeals.

It is further ADJUDGED AND ORDERED that, if successful in defending this Judgment in the Texas Supreme Court, Apache Corporation shall further recover: (1) SEVENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$75,000.00) for responding to a petition for review; and (2) ONE HUNDRED TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$125,000.00) in briefing on the merits and presenting oral arguments, if necessary.

This Judgment shall accrue interest at the rate of 5.5%, compounded annually from the date the Judgment is signed.

All other relief not expressly granted in this Judgment is DENIED. This Judgment is final and appealable.
